Trip Cancellation	Trip Cost	Reimbursement for the unused non-refundable pre-paid payments or deposits for the travel arrangements you purchased for Your Trip when you cancel for a covered unforeseen reason*. Emergency Accident and Sickness Medical Expense	\$50,000	Provides coverage for covered emergency medical expenses* such as an accidental injury or illness that strikes while on your trip.	Includes a \$50 deductible and a \$750 dental sublimit (applicable to natural teeth only).
Medical Evacuation and Repatriation of Remains	\$500,000	Offers protection in the event that emergency medical care is needed and an emergency evacuation to a better level of care is required. Also covers the costs associated with returning remains home in the event of a tragedy. - Pre-existing conditions are not covered under the policy unless:
